Applicant, _____ (Name of Applicant), hereby agrees to:

1. Tapping fees for domestic service is based on service line and meter size. For residential service, pay to MTMA, upon submission of this application, the total minimum Water Tapping Fee of \$3,999 and/or the minimum Sanitary Sewer Tapping Fee of \$1,472. These fees are based on a 3/4" water service connection and meter size in accordance with Resolution No. 14 of 2024. For larger commercial service, submit completed application to get an estimate of tapping fees;
2. Along with this complete application, submit a copy of the building permit application, plot plan, and completed application for service;
3. Pay any additional fees within 30 days of the issuance of an invoice from MTMA for costs related to this new service for reasons including but not limited to: a larger meter/service line size, presence of assessments, reimbursement district(s) or special purpose tapping fee district(s), state or county road occupancy permit fees as well as for construction work necessary to provide a point of sewer service connection to be billed on a time and material basis;
4. Construct and install all service lines and appurtenances in strict conformance with the Application information, MTMA specifications and applicable rules and regulations;
5. Comply with all MTMA rules and regulations regarding water and/or sewer service, and
6. Ground water, surface water, or roof drainage is not permitted to enter the sanitary sewer.

The Moon Township Municipal Authority hereby agrees to:

1. Connect the service line(s) to the main(s) upon completion of the construction and installation of the service line(s) in accordance with MTMA specifications, rules and regulations (if applicable); and
2. Install a water meter (if applicable); and
3. Provide water and/or sewer service to the premises in accordance with MTMA policies, rules and regulations.
